All Integra seating products with standard fabrics pass CA TB 117 fire code requirements, and are able to pass Technical Bulletin 133 using approved fabrics and fire barrier. Please consult Integra for more details.

#### **COM - CUSTOMER'S OWN MATERIAL**

Integra will work with customer's own material. All fabric needs to be sent to the factory for approval before an order is accepted. Following that approval, you will be advised of any additional yardage which may be required for your order and upcharges for special handling and/or hand cutting. Use Grade COM (1st column) pricing for orders, which includes the product and only the labor for the fabric's application. The cost of the fabric is the customer's responsibility. Orders must state supplier's name, pattern name and color. Shipments to Integra from COM suppliers must be tagged with purchase order numbers and ship freight prepaid. Order will not be put into a production schedule until receipt of goods (COM).

#### **WOOD SPECIES**

Most Integra product lines are constructed with <u>Hard Maple</u>. Please see price list for information.

#### **FREIGHT**

Integra's 2024 list prices include freight charges on all orders above \$10,000 List shipped to AZ, NM, CA, OR, WA, ID, MT & NV and all orders above \$7,500 List shipped within the rest of the continental United States. There is a minimum order freight charge of \$500 Net for orders under \$10,000 List to AZ, NM, CA, OR, WA, ID, MT & NV and \$300 Net for orders under \$7,500 List to the rest of the continental US. Shipments to Alaska and Hawaii, as well as international destinations, will be cartoned and shipped to the Port of Exit. Cartoning charges will apply. Customer is responsible for freight charges from the Port of Exit to final destination.

Integra's standard freight method is to set-up and blanket-wrap furniture for shipping. This requires coordination with the freight company in order to meet and unload the truck at the destination. The furniture is assembled and will need to be removed from the truck, inspected and set in place. In certain cases, and as an option, we can carton our furniture for shipping. Cartoning charges will apply.
